## M-Enabling Summit's Digital Platform Addresses the Future of Digital Accessibility

**BETHESDA, MD (October 13, 2020)** – "A New Reality for Digital Accessibility" was the fundamental theme of the **M-Enabling Summit Virtual Leadership Briefing** held on September 15, 2020. Due to the impact of COVID-19, the **M-Enabling Summit** team launched a three-part webinar, with leading innovators and advocates on digital game changers for Persons with Disabilities, in lieu of the annual leading conference on digital accessibility. The digital event successfully brought together over 1,300 participants from 56 countries which ranged from top industry executives, government officials, and community advocates.

The fast-paced, two-hour program featured dynamic interviews with some of the industry's top thought leaders, with engaging discussions amongst peers. The program provided a platform that reinforced better accessibility in the digital space as a key component of inclusion and sustainable success in these new and unprecedented times. Key topics included: Digital Accessibility Innovation - Leapfrogging into the Future, Reimagining Smart Inclusive Communities and The Best of 2020 Digital Accessibility Innovations.

Caroline Casey took part in a discussion during part-two of the webinar, stressing that *"we cannot have full inclusion in society if we do not have inclusion in businesses, it's about global representation and the power of influence."* Vint Cerf adding that *"the spirit of collaboration is key for inclusion and accessibility; we need to move from accessibility to usability."*
